Certificate of Public Convenience and Necessity No. G-49, stands in the name Donald Schatz, d/b/a Ted's Sanitary Service, and authorizes the service therein set forth.

Certificate of Public Convenience and Necessity No. G-101, stands in the name Waste Control, Inc., d/b/a Waste Control, and authorizes the service therein set forth.

Joint Application GA-78987 has been filed requesting authority to transfer all rights under said Certificate No. G-49, Donald Schatz, d/b/a Ted's Sanitary Service, to Waste Control, Inc., d/b/a Waste Control, holder of Certificate No. G-101.

It appears that the transfer of rights as herein requested will not be detrimental to interests of the public and that the transferee is fit, willing and able to conduct the involved transportation service.

ORDER

WHEREFORE, IT IS ORDERED That the application herein be, and the same is hereby granted and contingent upon the applicant having complied with the provisions of chapter 81.77 RCW and the rules relating to solid waste collection companies, that said Certificate No. G-49 standing in the name of Donald Schatz, d/b/a Ted's Sanitary Service, be cancelled; and that Certificate No. G-101, standing in the name Waste Control, Inc., d/b/a Waste Control, be amended as per the attached Appendix A.

IT IS FURTHER ORDERED THAT Donald Schatz, d/b/a Ted's Sanitary Service, file an Annual Report for the period January 1, 2001, to date of discontinuance, and remit annual regulatory fee based on the gross operating revenue from garbage collection operations.

All parties interested should take notice that the Commission in granting authority for the transfer of rights under a solid waste certificate does not necessarily approve the amount involved in the transaction, nor does it bind itself to recognize such amount in placing a value for ratemaking purposes on the property of the certificate holder.

All of Township 9 North, Range 2 East, W.M.

All of Township 9 North, Range 3 East, W.M.

All of Township 9 North, Range 4 East, W.M.

GARBAGE AND REFUSE COLLECTION SERVICE In that portion of Skamania County described as follows:

Sections 4 through 9, Sections 16 through 21, and Sections 28 through 33, Township 9 North, Range 5 East, W.M. Service is authorized to the west side of Spirit Lake only.

THE FOLLOWING AUTHORITY WAS OBTAINED BY TRANSFER OF CERTIFICATE NO. G-49, FROM DONALD SCHATZ, D/B/A TED'S SANITARY SERVICE.

GARBAGE COLLECTION SERVICE in that portion of Cowlitz and Clark counties described as follows: Starting at the southeast corner of Section 29, T5N, R1E; then west on the south line of said section projected to the east bank of the Columbia River; then following the east bank of said river northerly to the point where it intersects with the east-west centerline of Section 3, T5N, R1W; then east on the centerline of said section projected to the east line of Section 3,

T5N, R1E; then south on the east line of said section to the southeast corner of Section 22, T5N, R1E; then west on the south line of said section to the southwest corner of Section 21, T5N, R1E; then south on the west line of Section 28, T5N, R1E to the southeast corner of Section 29, T5N, R1E, the place of beginning.
