On June 20, 2001, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to initiate a rulemaking to update the adoption by references rules in the Pipeline Safety and Transportation chapters of Title 480 of the Washington Administrative Code.
