**BACKGROUND**

- 1 On August 28, 2002, in Docket No. TC-021022, the Commission granted the request of San Juan Transit, Inc., (San Juan Transit) holder of certificate of public convenience and necessity number C-1006, to temporarily discontinue service. Specifically, the authority to discontinue passenger transportation service on San Juan Island was granted for the period of September 2, 2002, to May 23, 2003.
  
- 2 San Juan Transit states in its petition that it has procured grant money that will allow the company to resume passenger transportation service on May 3, 2003, which is earlier than the original requested date of May 23, 2003. The company requests that the Commission grant permission to resume service May 3, 2003.
  
- 3 San Juan Transit holds auto transportation certificate of public convenience and necessity number C-1006 authorizing passenger transportation service on San Juan Island.

4 Commission Staff reviewed the petition and recommended that San Juan  
Transit's petition be granted.

### FINDINGS AND CONCLUSIONS

- 5 (1) The Washington Utilities and Transportation Commission is an agency of  
the State of Washington vested by statute with the authority to regulate  
public service companies, including auto transportation companies. *RCW*  
*80.01.040; Chapter 81.01 RCW; Chapter 81.04 RCW; Chapter 81.28 RCW and*  
*Chapter 81.68 RCW.*
- 6 (2) San Juan Transit is an auto transportation company subject to the  
jurisdiction of the Commission.
- 7 (3) This matter was brought before the Commission at its regularly scheduled  
meeting on April 23, 2003.
- 8 (4) The petition filed by San Juan Transit should be granted authorizing a  
resumption of service effective May 3, 2003.

### ORDER

#### THE COMMISSION ORDERS:

- 9 (1) The petition filed by San Juan Transit, Inc. , C-1006, d/b/a San Juan Transit,  
for permission to resume passenger transportation service authorized by  
the Company's certificate of public convenience and necessity is granted.
- 10 (2) Service will resume May 3, 2003.

The Commissioners, having determined this filing to be consistent with the public interest, directed the Secretary to enter this Order.
