2. There will be no charge for infants under 1 year who do not occupy a seat.
3. Adult and Child Advance Purchase Fares are only valid and available for reservations booked and paid for a minimum of 7 days prior to travel. No refunds or changes after booking. Capacity is controlled.
4. Child Advance Purchase/Free Fare is only valid and available for a child traveling with a full fare paying adult. Limit 1 Child/1 Adult. Reservations must be booked and paid for a minimum of 7 days prior to travel. No refunds or changes after booking. Capacity is controlled.
5. Child Fares are also available to all Travel Arrangers (persons in the business of arranging travel for others) on a space-available basis. No reservations are allowed under this fare.
