The amendment amends the interconnection agreement by adoption first accepted by the Commission on 1/22/2003 in Docket No. UT-033000. The adopted agreement was first approved by the Commission on 8/25/1999 in Docket No. UT-990378 between Company A and Company C, XO Washington Inc. (formerly Nextlink Washington, Inc.; now XO Communications Services, Inc.).

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
