AT&T Communications of the Pacific Northwest, Inc. ("AT&T") hereby files this motion requesting that the Washington Utilities and Transportation Corporation ("WUTC") grant an extension of time for AT&T to answer the Formal Complaint filed on behalf of Norse Home. On December 1, 2005, the WUTC sent the Formal Complaint via certified mail to an employee of AT&T's Finance--CFO-Controllers Organization. As a consequence, AT&T's Complaint Division employees did not receive service of the docketed formal complaint until Wednesday, December 7, 2005.

Upon receipt of the complaint, AT&T learned that its response is due on December 21, 2005. AT&T has performed a preliminary review of the account and complainant's allegations, but has not been able to reach a full resolution due to the complex nature of the issues. In addition, with the impact upon resources caused by the holiday season as well as the delay in receipt of the complaint, AT&T finds it necessary to request additional time to provide its answer. AT&T will make every effort to investigate and respond to the complainant as expeditiously as possible. AT&T respectfully requests that the Commission extend AT&T's Answer due date up to and including January 4, 2006.
