Rates in this item apply:

- (1) To solid waste collection, curbside recycling (where noted) and yardwaste collection services (where noted) for residential property. This includes single family dwellings, duplexes, apartments, mobile homes, condominiums, etc., where service is billed directly to the occupant of each residential unit; and/or
- (2) When required by a local government service level ordinance solid waste collection, curbside recycling, and yardwaste service must be provided for single-family dwellings, duplexes, mobile homes, condominiums and apartment buildings of less than ____ residential units, where service is billed to the property owner or manager.

Note 2: Recycling program charge (in addition to residential garbage rates) is \$ 3.90. Additionally, these customers will receive a commodity price adjustment (cpa) of \$(0.88) (A) (credit) per month. Recycling only service is \$4.90 adjusted for the cpa.

Item 105 – Multi-family recycling service

Rates in this item will apply to duplexes, apartment complexes containing 4 or less units, mobile homes and courts, condominiums, etc. where service is billed to and paid by the residential property owner or manager. Service is the same as single-family recycling service as described in item 100 with one bin set provided to each residence.

Rates:

In addition to regular charges in items 240 through 275 the following charges apply:

- (a) \$3.90 per residence for participants
- (b) \$3.90 (R) per residence for non-participants
- (c) customers will receive a (0.88) (A) (credit) for commodity prices.
