3. The temporary .30% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of January 2007 and February 2007, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of April 2007 & May 2007.

Customers who are billed bi-monthly for services -current month and one month ahead:
The surcharge will appear on the April 2007 billing and applies to all services provided in the months of April 2007 and May 2007 and in the May 2007 billing to all services provided in the months of May 2007 and June 2007.
