The adopted agreement was originally approved by the Commission on August 17, 2005 in Docket No. UT-053046 between Company and A and Company C, Trans National Communications International, Inc.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest.
