TO ALL INTERESTED PERSONS:

On June 4, 2008, the Washington Utilities and Transportation Commission (Commission) filed with the Office of the Code Reviser a Preproposal Statement of Inquiry (CR-101) to examine the need to remove the annual vehicle fee for non-profit transportation providers from rule and allow the Commission to set the fee by order each year. This allows the Commission more flexibility in adjusting the fee, either up or down, to meet the intent of RCW 81.66.030, which requires the Commission to charge fees that approximate the cost of regulation.

The Commission is not considering any changes to the current fee as a part of this rulemaking.
