B. POVA will provide all labor costs to remove old materials, assemble new signs to the post, set new posts as well as clean up and disposal of all old warning devices. In addition, POVA will be responsible for all costs for materials above the \$250 per crossing allowance.

4. ESTIMATED TIMELINE:

Once funding is approved POVA will order all materials for the crossings. The actual work will take approximately four (4) weeks to complete.

5. OTHER INFORMATION:

POVA's warning devices overall are old and need updating:

- Crossbucks are losing reflectiveness
- No Yield Signs
- Posts are rotting
- Missing or no reflective strip on posts.
- After completing our crossing inventory and comparing our records to USDOT information as well as WUTC and
 County Road Department information we have determined that five (5) crossings are public access roads that were not
 previously marked as such. These five roads are listed as items 20 through 24 on item # 2 and will need completely
 new signs to show that they are indeed considered County Roads and therefore are public crossings.

With State assistance we will be able to take and upgrade the public crossings for improved safety.
