**Commuter fares:** **Adult (18 yrs and up)** Commuter fare books, containing 20 tickets with no expiration date, will be sold between any of the above-named points and on-line for \$140

**6-18 yrs** Commuter fare books, containing 20 tickets with no expiration date, will be sold between any of the above-named points and on-line for \$70

**Child (to 6 years)** Commuter fare books, containing 20 tickets with no expiration date, will be sold between any of the above-named points and on-line for \$20

**Caged Pet** Commuter fare books, containing 20 tickets with no expiration date, will be sold between any of the above-named points and on-line for \$40

**Un-Caged Pet** Commuter fare books, containing 20 tickets with no expiration date, will be sold between any of the above-named points and on-line for \$80

**Adult fares:** Fares published are adult fares, applying to all passengers who have reached or passed their 18th birthday.

**Youth fares:** Children between 6 and 18 years of age, will be charged 50%.

**Child** Infant up to 6 years of age will be charged 20%.

**Pet fares:** Pets, carried on in cages riding either under seats or in the luggage compartment will be charged 20% Pets not in carriers will be charged 40%

**Owner Discounts** Owners of properties within Hat Island Community will be given the following discounts:

**Adults** 20% off published rate or \$8.00 one way

**Youth** 20% off published rate or \$4.00 one way

**Child** 50% off published rate or \$1.00 one way

**Ticket limitations:** One-way tickets have no expiration date.

Annual passes are valid for one-year from the date of purchase.

**Ticket redemption:** Tickets are redeemable at the Island Office during normal business hours; there is no limitation on time.

**Schedule maintenance:** The carrier will not be liable for delays caused by accidents, breakdowns, storms, or other conditions beyond its control. Every effort will be made to meet the published time schedule, the carrier makes no guarantee to arrive at, or depart from, any point at a specific time.

**Objectionable passengers:** The Company reserves the right to refuse to transport persons under the influence of drugs or liquor, or people who are incapable of taking care of themselves, or whose condition, conduct, or behavior may be objectionable to other passengers.

**Baggage rules and charges:** Free carriage of hand baggage weighing less than 50 pounds per adult and 25 pounds per child. There is no additional fee for excess baggage, however excess baggage may be refused passage if the ferry is full and that excess baggage places the vessel in an overweight condition

**Animals:** Dogs, cats, and other animals or birds will be carried under the following conditions:

Pets must be on a leash and muzzled, or carried in approved pet carrier.

Pets not in carriers are only allowed on the upper decks at the following

rate: \$4.00 one-way. Pets in carriers on either deck or in the luggage compartment at the following rate: \$2.00 one-way. Owners are responsible for cleaning up after any mess made by their pet. Non Owners are not permitted to transport animals to Hat Island nor transport them on the Hat Island Ferry.

***Exception:** Dogs traveling with sight or hearing-impaired passengers will be carried free of charge. The dogs will not be permitted to occupy a seat, but must lie or stand at the feet of the passenger.*

1. The captain has final authority to determine what cargo may be carried on the vessel.
2. The captain has the final authority to determine if the weather is safe for running the ferry.
3. No building materials may be carried on the ferry except (in certain circumstances, those for Community maintenance work.)
4. No flammable materials on the ferry, including lawn mowers and gas cans.
5. There is no smoking allowed anywhere on the ferry.
6. Guests may not bring animals to the island.
7. All pets are the sole responsibility of the property owner. Owners of animals deemed to be dangerous or a nuisance will be warned ONCE only.
8. Any owner who does not clean up after his or her pet will be warned once and may be denied boarding privileges.
9. Certain cargoes such as bicycles are on a space-available basis. A round trip may not be guaranteed for all items for all trips.
