Willamette Valley Student Movers, LLC, d/b/a/ Gator Movers, is no longer authorized to operate as a household goods carrier under this operating authority.
- 5 (2) The application for permanent household goods authority in Docket TV-101216 is dismissed.
- 6 The Commission has delegated authority to the Secretary to enter this Order under RCW

7 80.01.030 and WAC 480-07-905(1)(h).
