BACKGROUND

- 1 Household goods carriers operating in the state of Washington and subject to regulation by the Washington Utilities and Transportation Commission (Commission) must file and maintain proof of liability and property damage insurance. RCW 81.80; WAC 480-15.
- 2 On June 28, 2011, the Commission notified Great West Moving and Storage, Inc., (Great West), by letter that the Commission would suspend the Great West's permit to operate as a household goods carrier in Washington State if Great West did not file acceptable proof of insurance by the insurance cancellation date. The Commission also informed Great West, that it could contest suspension of its permit by requesting a hearing within 10 days of the notice. The Commission did not receive proof of insurance and Great West did not request a hearing.
- The Commission subsequently suspended Great West's permit for a period of 30 days effective July 28, 2011. In the suspension order, the Commission informed Great West Moving and Storage, Inc., that it would cancel its permit if Great West did not file acceptable proof of insurance within the 30-day suspension period. The Commission also notified Great West it could contest cancellation of the permit by requesting a hearing within 10 days of service of the suspension order. The Commission has not received proof of insurance and Great West has not requested a hearing.

DECISION

4 Great West Moving and Storage, Inc. has failed to maintain acceptable proof of liability and property damage insurance as required by applicable law. Accordingly, the

Commission should cancel Great West's permit to operate as a household goods carrier in Washington State.

FINDINGS AND CONCLUSIONS

- 5 (1) The Washington Utilities and Transportation Commission is an agency of the state of Washington having authority to regulate household goods carriers as defined in RCW 81.80.
- 6 (2) Great West Moving and Storage, Inc., is a household goods carrier operating in Washington state under permit THG-61024.
- 7 (3) On June 28, 2011, the Commission received notice that Great West Moving and Storage, Inc.'s insurance would be cancelled effective July 28, 2011.
- 8 (4) The Commission suspended Great West effective July 28, 2011, for failure to maintain proof of liability and property damage insurance.
- 9 (5) The Commission is authorized under WAC 480-15-430(1)(b) to suspend a household goods permit for failure to file and maintain proof of insurance.
- 10 (6) The Commission is authorized under WAC 480-15-150(1)(b) to cancel a household goods permit for failure to correct conditions leading to suspension within the time defined in the suspension order.

<u>ORDER</u>

THE COMMISSION ORDERS:

- 11 (1) The household goods permit and provisional operating authority THG-61024, held by Great West Moving and Storage, Inc., is cancelled.
- 12 (2) Great West Moving and Storage, Inc., .must immediately cease all operations associated with permit THG-61024. Great West Moving and Storage, Inc., is no longer authorized to operate as a household goods carrier under this operating authority.
- 13 (3) The application for permanent household goods authority in Docket TV-100734, is dismissed.

- 14 (3) Great West Moving and Storage, Inc., may contest cancellation of permit THG-61024 by requesting a hearing within 10 days of service of this Order.
- The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030, WAC 480-07-905(1)(h).

If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.
