Northwest Natural Gas Company, dba NW Natural (NW Natural or Company), files herewith the following revisions to its Tariff WN U-6 stated to become effective with service on and after **June 1, 2013**:

The purpose of this replacement filing is to (1) add language to Sheet 141.2 and Sheet 142.2, respectively, to further clarify the effect on a customer if they do not request a change under the annual service election provisions, (2) to make additional clarifying changes to the Sales Service Type section, and (3) to make the same changes proposed under the Sales Service Type section of Sheet 141.2 and Sheet 142.2 to the Combination Service Type section on Sheet 141.3 and Sheet 142.3, respectively.

The tariff sheets proposed by the Company in NWN Advice WUTC 13-1 dated April 19, 2013 are hereby withdrawn in the entirety and replaced with the tariff sheets included with this replacement filing.

The Company respectfully requests that the tariff sheets filed herein be approved to become effective with service on and after June 1, 2013.

As required by WAC 480-80-103(4)(a), I certify that I have authority to issue tariff revisions on behalf of NW Natural.
