Enclosed you will find our check for \$200 in payment of the penalty assessment for TG-131177. We certainly appreciate that the potential \$800 penalty was reduced to \$200. We are not asking for mitigation but would like an explanation of circumstances added to our file.

My husband, Fred, and I have operated this company since 1975. It is our intention to be in compliance with all laws and rules at all times. We have almost no filed complaints and no violations that I am aware of.

During the month of April, Fred became unexpectedly ill with heart related issues. During that time we went to the hospital five times and he was admitted four times. This health crisis was completely unexpected and necessitated many trips during the entire month to the hospital and doctors for testing, etc. This emergency consumed much of the time I would have spent preparing the annual report. In desperation early on April 30th, I contacted Rae Lynn Carnes at the Commission for suggestions about possible late filing.

Per enclosed email copy, she responded that as long as I had a written request in on April 30th and submitted payment for the regulatory fee I could be granted an extension. I responded to her email requesting the extension and attached the regulatory payment authorization at 3:03 PM on April 30th. Her email did not indicate that I needed to send the request on letterhead or that a written email request would not suffice. On May 1, I received an email from Rae Lynn Carnes that my request needed to be on letterhead. I resubmitted the request on letterhead at 10:53 AM on May 1.

Again, we greatly appreciate the reduction in our penalty but feel that our email requesting the extension was timely according to instructions we received. Thank you for taking time to read our explanation.
