BACKGROUND

1 On March 21, 2014, Enterprise Focus, Inc, d/b/a megabigpower.com, filed with the Washington Utilities and Transportation Commission (Commission) an application for registration and petition for classification as a competitive telecommunications company in Docket UT-140458. The application and petition do not comply with the rules set forth in WACs 480-120 and 480-121.

FINDINGS AND CONCLUSIONS

2 Enterprise Focus, Inc., d/b/a megabigpower.com, is not registered with the Department of Revenue. It's application and petition are therefore not in compliance with the rules set forth in WACs 480-120 and 480-121 and should be rejected.

ORDER

3 **THE COMMISSION REJECTS** the application and petition of Enterprise Focus, Inc., d/b/a megabigpower.com, in its entirety. This Order does not preclude Enterprise Focus, Inc., d/b/a megabigpower.com, from filing a later application and petition for registration as a competitive telecommunications company.

4 The Commissioners, having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
