We received your Notice of "Penalties Incurred and Due" letter on June 4, 2014.

We firmly believe that one or more of the alleged violations did not occur, for the following reasons:

- 1. Telewise's <u>Telecommunications Companies 2013 Annual Report</u> was **submitted by Electronic Filing on April 30, 2014**. This is one day PRIOR to the May 1<sup>st</sup> due date.
- 2. Upon completion of Electronic Filing, Telewise received an E-file Confirmation ID: 541 from the UTC along with the following message: "Your electronic filing has been successfully submitted. You will receive an e-mail notification shortly to confirm that we have received your submission."
- 3. On April 30, 2014 at 6:31pm Telewise received UTC E-Filing submission received, confirmation ID 541 E-mail message, with the following instruction: "Please save this e-mail, and use the confirmation ID when contacting the Commission".
- 4. Telewise's Total Gross Intrastate Operating Revenue for 2013 was \$4,191. As indicated on the UTC Regulatory Fee Caculation Schedule: *"If Line 3 is UNDER \$20,000, enter ZERO (skip to Line 5); Total Regulatory Fees owed: \$0."* No payment was due.

Because we submitted our Electronic Filing on April 30, 2014 and received confirmation that our filing was received by the UTC, we believe the penalty should be excused.
