Staff's Request to Rescind Penalty Assessment  
Docket TG-141015

Dear Mr. King:

On May 22, 2014, the Utilities and Transportation Commission issued a \$200 Penalty Assessment in Docket TG-141015 against Rabanco LTD for 2 violations of Washington Administrative Code (WAC) 480-70-071, which requires solid waste companies to furnish annual reports to the commission no later than May 1 each year.

The company submitted the annual report via US Mail which was received by the commission on May 5. Since the penalty assessment was issued, it has been discovered that the annual report was also delivered via online filing on May 1 as an attachment to the company's Affiliated Transaction Report filing. As Rabanco LTD timely filed its 2013 annual report on May 1, 2014, staff recommends that the assessed penalty be withdrawn and the docket closed.
