Pursuant to WAC 480-90-198 and WAC 480-100-198, Notice Verification and Assistance, Puget Sound Energy, Inc. ("PSE") is providing this statement that it published the attached notice in the above-referenced dockets in accordance with WAC 480-90-194 and WAC 480-100-194, Publication of Proposed Tariff Changes to Increase Charges or Restrict Access to Services.

On October 30, 2014, PSE filed with the Commission the annual update of the Federal Incentive Tracker (Schedule 95A – Docket No. UE-143784). On November 20, 2014, PSE filed with the Commission revisions to Schedule 137 (Docket No. UE-143951) to pass through benefits from sales of renewable energy credits ("RECs"). On November 25, 2014, PSE filed with the Commission revisions to Schedule 132 (Merger Rate Credit – Docket Nos. UE-143992 and UG-143993). All four filings reflect requested effective dates of January 1, 2015. In order to communicate the best possible data regarding the change in rates on January 1, 2015, PSE created a single notice encompassing all of these filings. Due to the changes proposed in these filings all 1,094,045 of PSE's electric customers will see an increase in their bill. Due to the change in the Merger Rate Credit, 728,928 of PSE's 786,183 natural gas customers will see an increase in their bill and 57,255 will see a decrease in their bill.

WAC 480-100-198 provides that within ten days of making a filing requiring publication, but no sooner than when the tariff is filed with the commission, a utility must file a statement that the required notice has been published. The Schedule 95A filing was made on October 30, 2014, in order to allow Commission Staff more than 30 days to review the filing. Publication of the notice on December 1, 2014, does not meet the 10 day requirement. WAC 480-100-194 provides that publication of the required notice be made at least 30 days prior to the effective date of the filing. The Schedule 95A filing has a requested effective date of January 1, 2015. Publication of the notice on December 1, 2014 meets the requirements of WAC 480-100-194. PSE respectfully requests a waiver of WAC 480-100-198 since combining the impacts of all January 1, 2015, changes provides a clearer message to customers compared to multiple messages.

PSE will also provide a copy of the notice to community agencies, has posted the notice on PSE.com and has provided notice to news editors of area newspapers, television and radio stations.
