Subject of possible rule making: The subject of this inquiry is to consider whether the Utilities and Transportation Commission (Commission) should develop a new rule and/or modify existing rules in WAC 480-90 (Gas Companies) and WAC 480-100

(Electric Companies) to address problems with inaccurate energy usage melectric and natural gas customers. Reasons why rules on this subject may be needed and what they might accomplish: The Commission is responsible for protecting consumers by ensuring that investor-owned utility services are fairly priced, available, reliable, and accurate. Consumers have a right to timely and accurate bills each month. It is reasonable to expect utilities to identify and correct stopped meters, as well as, unidentified energy usage within a reasonable timeframe. Initial data provided by the utilities indicate that customers are continuing to receive retroactive bills for periods in excess of six months, and in some cases, more than 12 and 24 months. A rulemaking would establish common standards for all the regulated energy utilities.
