

RESOLUTION NO.

REGARDING TEMPORARY AMENDMENT OF SOLID WASTE DISPOSAL RATES

WHEREAS, pursuant to RCW 36.58.040, the Skagit County Board of Commissioners is responsible for the establishment of solid waste rates and classifications of rates; and

WHEREAS, the Skagit Board of County Commissioners did, by Resolution No. R20130358 on December 3, 2013, establish Solid Waste disposal rates for Skagit County; and

WHEREAS, Skagit County Public Works has recently completed construction of a street waste decant facility ("Skagit County Decant Facility") located at the Skagit County Transfer Station; and

WHEREAS, the Skagit Board of County Commissioners desires to establish an initial rate structure for the Skagit County Decant Facility (and it is anticipated that such temporary initial rate structure may be revised and permanently established after the Skagit County Decant Facility has been in operation for a longer period of time); and

WHEREAS, on April 30, 2008 the Board of Skagit County Commissioners entered into the Interlocal Cooperative Agreement Between Skagit County and Cities and Towns In Skagit County for Solid Waste Management (Skagit County Contract #C20080306; as amended by Amendment # A20100124), which established the Skagit County Solid Waste System Governance Board ("SWSGB"); and,

WHEREAS, the SWSGB reviewed and approved the initial rate structure for the Skagit County Decant Facility; and,

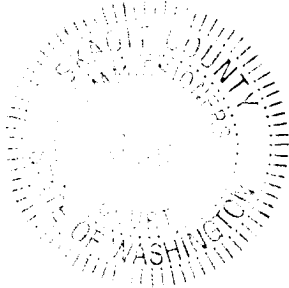
WHEREAS, the Skagit Board of County Commissioners desire to rescind Resolution # R20130358 and implement the Solid Waste Disposal Rates as detailed in Attachment "A".

NOW, THEREFORE, BE IT RESOLVED AND HEREBY ORDERED by the Board of Skagit County Commissioners that the rates established by Resolution # R20130358 are hereby rescinded, and are hereby replaced and superseded with the schedule of rates shown on Attachment "A" of this Resolution, effective immediately.

BE IT FURTHER RESOLVED, that the current State of Washington Refuse collection tax be included in the rates for non-exempt customers.

A. GENERAL WASTE:

C. SPECIAL WASTE:

1. **Roadside Litter** \$ 0.00 / ton
Only litter that is collected by non-profit organizations or public service organizations from public rights-of-way. Subject to prior approval.
2. **Recyclable Materials** \$ 0.00 / ton
Materials from households consisting of entirely clean and separated recyclables in the following categories:
 - a. Glass: separated by colors (brown, clear, and green)
 - b. Metal Containers: separated by type (tin, aluminum)
 - c. Paper: separated by type (newspaper, cardboard, mixed paper)
 - d. Other Scrap Metals: all non-metal materials must be removed
4. **White Goods (Appliances)**
White Goods containing chlorofluorocarbons: \$25.00 each
White Goods not containing chlorofluorocarbons: \$10.00 each
5. **Tires**
Only passenger car and light truck tires are accepted, must be separated.
Charged at General Waste Rate.

D. OUT-OF-COUNTY WASTE:

Out-of-County wastes delivered by residential customers are **NOT** accepted at any Skagit County solid waste disposal site.

The following waste Out-of-County waste streams are accepted at the Skagit County Recycling and Transfer Station:

Domestic waste from Whatcom County, which is collected by commercial haulers along State Highway 20 north of the Skagit County line.

Only residential wastes are accepted at the satellite collection sites.

F. MATERIALS NOT ACCEPTED AT SKAGIT COUNTY DISPOSAL SITES:

- a. Petroleum contaminated soils
- b. Grease – food preparation wastes
- c. Asbestos containing materials
- d. Catalyst
- e. Sod, seeds, bulbs, or sawdust
- f. Hazardous, liquid, or chemical wastes

G. Direct to Intermodal Construction and Demolition Residual Materials

Pursuant to and subject to compliance with Skagit County Code 12.18.040, residual waste generated by the processing of construction and demolition debris at a permitted intermediate solid waste handling facility may be delivered directly (in a sealed intermodal container acceptable to the County) to an intermodal facility utilized by Skagit County for the transport and/or disposal of solid waste, contingent upon compliance by the intermediate solid waste handling facility with certain requirements, including:

The intermediate solid waste handling facility shall pay Skagit County a fee (and comply with audit and verification procedures) as follows:

Recycling Rate of 75% - 79%	\$15.00 / ton discount
	(\$74.00 / ton)

Recycling Rate of 80% or better	\$25.00 / ton discount
	(\$64.00 / ton)

In order to qualify for the above-stated discounted rate, a minimum recycling percentage of seventy-five percent (75%) must be maintained by the intermediate

solid waste handling facility (the intermediate solid waste handling facility shall ensure that a minimum of seventy five percent [75%] of the construction and demolition debris materials received by the intermediate solid waste handling facility are processed and marketed for recycling or energy recovery, with no more than twenty five percent [25%] of incoming materials by weight being delivered to the intermodal facility for disposal). Obtaining a discounted rate (as provided above) is subject to the intermediate solid waste handling facility complying with audit and verification policies and procedures to be established and adopted by the Director of Public Works, including auditing and verification of all information submitted to the County by the intermediate solid waste handling facility. Such audit and verification policies and procedures shall require the intermediate solid waste handling facility to provide a detailed accounting of materials processed and stored at the intermediate solid waste handling facility and shall be submitted to the County by the intermediate solid waste handling facility on or before the 5th day of each month. Required information to be submitted by the intermediate solid waste handling facility shall include, but is not necessarily limited to, incoming waste volumes, incoming waste by weight, types and volumes of materials stored on-site, shipments of recyclable materials including material type, volume, and destination, and amount, type, and destination of materials marketed for energy recovery (and such other information that the Skagit County Public Works Department determines to be necessary or appropriate).

H. SWEEPER / VACTOR DECANT WASTE

Street waste resulting from street and catch basin cleaning activities accepted by the County at the Skagit County Decant Facility. All Skagit County Decant Facility customers shall require pre-authorization by the County.

I. HOUSEHOLD HAZARDOUS WASTE

Acceptable wastes must be separated and delivered to the Skagit County Household / Moderate Risk Waste Facility.

J. MODERATE RISK WASTE

Only Moderate Risk Waste from qualifying Small Quantity Generators is accepted.

All materials will be charged by container size, rounded up to 1 gallon increments.

Reactive Materials

Includes Dangerous When Wet, Spontaneously Combustible, and Flammable Solid categories. Reactives will be accepted only on a case-by-case basis, as decided by the Hazardous Waste Specialist.

Reactive Material \$38.00/gallon

Oxidizing Materials

Oxidizing Material \$20.00/gallon

Organic Peroxides

Due to the potentially shock sensitive nature of these materials, organic peroxides will be accepted only on a case-by-case basis, as decided by the Hazardous Waste Specialist.

Organic Peroxides \$38.00/gallon

Solid Organic Resins, Tars, Adhesives, Paints, etc.

Solid Organics \$7.00/gallon

Antifreeze

Antifreeze \$3.00/gallon

Motor Oil

Motor Oil, Uncontaminated \$0.25/gallon

Mercury Containing Lamps

Florescent Lamps	\$0.10 / linear foot
Compact Florescent Lamps	\$0.25 / lamp
HID Lamps	\$1.00 / lamp

Unclassified Wastes

For chemical waste streams not directly correlated to the above classes, disposal rates will be based on treatment technology and handling requirements as follows:

Class I	\$ 6.00/gallon
Class II	\$12.00/gallon
Class III	\$18.00/gallon
Class IV	\$24.00/gallon
Class V	\$30.00/gallon
Class VI	\$36.00/gallon
