In accordance with WAC 480-07-640, Company A requests approval of the fully negotiated amendment to an interconnection agreement, as described below:

Amendment Number: 8*

Description of amendment: Amends the agreement reflecting implementation of the FCC's Intercarrier Compensation Reform Timeline as provided in the *USF/ICC Transformation Order FCC 11-161 (rel. November 18, 2011)*.

*Note: This document is titled "Amendment No. 7" by the parties to the agreement. It is designated as the 8th amendment in this form at the Commission Staff's request, for tracking purposes.


The amendment amends the interconnection agreement first approved by the Commission on August 25, 1999

in WUTC Docket No. UT-990378.
