Household Goods and General Commodities (excluding Armored Car Service and Hazardous Materials) in the state of Washington.

The authority in this permit is temporary to allow Jorge H. Luna Lopez, d/b/a EDL Movers, an opportunity to provide service as a household goods carrier on a provisional basis for six months during which time the commission will evaluate whether the applicant has met the criteria for obtaining permanent authority under the provisions of WAC 480-15-305.

The authority granted in this permit is only effective while the applicant complies with the terms and conditions of Docket TV-144050 and only until such time as the commission, by further order grants, denies, or, dismisses the application for permanent authority in Application TV-144050, or otherwise cancels the authority granted.

This permit shall automatically terminate upon either the entry of a commission order granting or approving withdrawal of Application TV-144050 for permanent household goods carrier authority, or in case Application TV-144050 is denied, dismissed, or the relief sought under Application TV-144050 is limited in any way by commission order upon the expiration of the last day for seeking review of the commission order or a later date fixed by order of a reviewing court.
