ORDER 01

ORDER GRANTING PETITION TO CLOSE AN AT-GRADE HIGHWAY-RAIL CROSSING AND REPLACE IT WITH AN OVERCROSSING AT WILDLIFE REFUGE ROAD IN RIDGEFIELD

USDOT: 092425R

BACKGROUND

- On May 25, 2017, the United States Fish and Wildlife Service (USFWS or Petitioner) filed with the Washington Utilities and Transportation Commission (Commission) a petition seeking approval to close an at-grade highway-railroad grade crossing and replace it with an overcrossing. The crossing is identified as USDOT 092425R and is located at the intersection of Wildlife Refuge Road and the Respondent's tracks in Ridgefield. The new overcrossing USDOT number is to be assigned.
- 2 Respondent BNSF Railway Co. (BNSF) consented to entry of an Order by the Commission without further notice or hearing.
- Wildlife Refuge Road is a two-lane rural local road owned by the USFWS and provides access to the Ridgefield National Wildlife Refuge. The average annual daily vehicle traffic over the crossing is estimated at 100 vehicles. Wildlife Refuge Road is not part of an established truck or school bus route and the posted vehicle speed limit is 10 miles per hour. There are two mainline tracks at this location. Approximately 59 freight trains travel over the crossing daily at 60 miles per hour, and six passenger trains travel over the crossing daily at 79 miles per hour.
- 4 Current railroad warning devices at the Wildlife Refuge Road crossing consist of cantilever-mounted lights and gates, crossbucks, and advance warning signs.
- The proposed overcrossing will retain the same number of vehicle travel lanes and will not intersect the railroad tracks at grade. As a result, no warning signs or signals are necessary at the crossing. The overcrossing will provide motorists with safe passage over the tracks because of the separation between the railroad tracks and users.

Traffic and workers will continue to use the existing crossing until the overcrossing is complete. Once the overcrossing is complete, traffic will be re-routed to the new overcrossing and access to the existing at-grade crossing will be removed. At that time, the existing signage, crossing surface, and signal equipment at the at-grade crossing will be removed.

FINDINGS AND CONCLUSIONS

- 7 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington having jurisdiction over public railroad-highway grade crossings within the state of Washington. *RCW* 81.53.
- The railroad-highway grade crossing at the intersection of Wildlife Refuge Road and the Respondent's tracks in Ridgefield, Washington, identified as USDOT 092425R, is a public railroad-highway grade crossing within the state of Washington.
- 9 (3) RCW 81.53.261 requires the Commission grant approval prior to any changes to public railroad-highway grade crossings within the state of Washington in non-first class cities. See also WAC 480-62-150.
- 10 (4) Commission staff investigated the petition and recommended that it be granted, provided that upon completion of the construction, the Petitioner must notify the Commission. The crossing is subject to inspection by Commission staff, verifying that it is in full compliance with applicable laws and regulations.
- 11 (5) After reviewing USFWS's petition filed on May 25, 2017, and giving due consideration to all relevant matters and for good cause shown, the Commission grants the petition.

ORDER

THE COMMISSION ORDERS:

The United States Fish and Wildlife Service's petition to close an at-grade railroadhighway grade crossing and construct an overcrossing at the intersection of Wildlife Refuge Road and the Respondent's tracks in Ridgefield, Washington, is granted. Approval of the petition is subject to the following condition: (1) The Petitioner must notify the Commission upon completion of the construction. The crossing is subject to inspection by Commission staff, to verify that it is in full compliance with applicable laws and regulations.

The Secretary of the Commission has delegated authority over this matter pursuant to Order 01 in Docket A-151775. The Secretary finds this Order to be consistent with the public interest.
