Thunder Ridge Water Co., Inc. has filed for approval from the Washington Utilities and Transportation Commission to increase its annual revenue by approximately 75%. This is the first increase ever in the base rate. The reason for the rate increase is to cover increased costs of administration due to meter reading and billing, to adjust for ever-increasing costs of operation (i.e. electricity, testing, maintenance/repair, etc.) and to make it a sustainable operation. It will also be more equitable since the bills will be based upon usage. The new tariff will also provide for meter readings on the 15th of the month, with bi-monthly billing. Below is a comparison of current and proposed monthly rates, proposed to take effect on Dec. 15, 2017.

The average customer, using 5,349 gallons of water per month, will see a bill increase from \$30 to \$54 per month.
