RATE INCREASE NOTICE FOR COMMERCIAL ROLL-OFF AND COMPACTOR SERVICE

Dear Customer:

February 28, 2018

Columbia River Disposal, Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC October 1, 2016. Since that time, the Company has experienced increases in operating costs in the areas of labor, employee benefits, fuel, parts and equipment amongst other categories which it now seeks to update in rates.

If approved, the proposed rates will become effective April 1, 2018. The rate per month will increase as follows:
