WATER RATES

The following rates for water service available to all residential, commercial, and industrial customers shall be applicable for all water consumed for residential, commercial, or industrial purposes. Meters shall be read to the nearest 100 cubic feet.

A meter may be billed at the residential rate so long as no more than 25 percent of the total water requirement is for commercial purposes.

PRIVATE FIRE PROTECTION

Monthly charges for water availability for private fire sprinkler systems and hydrants installed on private property are established for each water system based on the size of the water line.

It is the customer's responsibility to evaluate private fire protection requirements and to verify the adequacy of the District's water system to meet those requirements.

DISCRETIONARY CLAUSE

The General Manager is authorized to interpret and direct the application of any and all sections of this document.
