Re: Adoption-by-Reference Rule Revisions in Title 480 WAC
Docket A-181038

TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) has filed with the Code Reviser proposed revisions to the adoption-by-reference rules in Title 480 of the Washington Administrative Code (WAC). The Commission filed the proposed changes as an expedited rulemaking (CR-105) under Docket A-181038.

This proposal would revise adoption-by-reference dates to reflect the most current published versions of adopted federal rules and other adopted publications.

THE COMMISSION HEREBY GIVES NOTICE of the opportunity to submit written comments on the proposed rules by filing with the Commission's Executive Director and Secretary by electronic transmission as described below, or by physical delivery to 1300 S.
