PSE’s Electric Tariff Filing - Filed Electronically**

Dear Mr. Johnson:

Puget Sound Energy (“PSE”) hereby submits proposed revisions to its electric Schedule 57, Continuous Lighting Service. This filing, pursuant to RCW 80.28.060 and Chapter 480-80 WAC, proposes revisions in the following tariff sheets.

- WN U-60, Tariff G - (Electric Tariff):
- 32nd Revision of Sheet No. 57 – Continuous Lighting Service
- Original Sheet No. 57-A – Continuous Lighting Service (Continued)

With significant growth in PSE’s service territory, there has been a steady increase in the types and quantities of traffic control devices and fixtures. Municipal customers increasingly reach out for information to meet their application review and approval timelines. The purpose of this filing is to add clarifying language for unmetered service provided under Schedule 57, Continuous Lighting Service that is similar to language in Schedule 53, Street Lighting Service. The proposed revisions address the various types of devices and fixtures that can be served, and obligations regarding the determination of connected load, inventory management, and audits for both PSE and its customers. These updates will help PSE’s implementation and administration of this service and better support the needs of its customers.

The tariff sheets described herein reflect an issue date of April 22, 2019, and an effective date of May 31, 2019. As required by WAC 480-100-193, PSE is posting the proposed tariff sheets on the PSE web site coincident with the date of this transmittal letter. Publication under WAC rules is not required as the proposed addition of clarifying language does not represent a restriction of service nor an increase in rates.
