**RE: Advice 19-05—Schedule 97—Power Cost Adjustment Mechanism Adjustment**

Pacific Power & Light Company (Pacific Power), a division of PacifiCorp, submits the following revised tariff sheets in accordance with RCW 80.28.050, WAC 480-80-121, and WAC 480-07-885. Pacific Power respectfully requests an effective date of November 1, 2019.

The revised tariff sheet is designated as follows:

Second Revision of Sheet No. 97.1    Schedule 97    Power Cost Adjustment Mechanism Adjustment

In compliance with Orders 01 and 02 in Docket UE-180494, Pacific Power set the rate for Schedule 97 to refund \$17,899,494 to customers over 12 months, effective November 1, 2018. Accordingly, Pacific Power is now submitting a revised tariff to zero out Schedule 97 as the 12-month period comes to an end on October 31, 2019.

The expiration of the Power Cost Adjustment Mechanism Surcredit will result in an overall average increase of approximately 5.1 percent to Pacific Power's Washington customers. If approved, a residential customer using approximately 1,200 kWh per month will see a bill increase of approximately \$5.88 per month. Attachment C is the company's proposed Schedule 191 tariff sheet, which lists the proposed rate changes by rate schedule.

In accordance with WAC 480-100-194(2), the company is informing customers through a published notice. The customer notice is enclosed as Attachment D.
