RE: *Washington Utilities and Transportation Commission v. Luxury1 Limo, LLC*
Commission Staff's Recommendation to Cancel Payment Arrangements and Dismiss
Application
Dockets TE-180596 and TE-191008

Dear Mr. Johnson:

On December 9, 2019, Luxury1 Limo, LLC, (Luxury1 or Company) filed an application with the Washington Utilities and Transportation Commission (Commission) in Docket TE-191008 for reinstatement of its charter and excursion service certificate.

On February 25, 2020, the Commission entered Order 02 in Docket TE-180596, which denied Luxury1's request for the Commission to waive the Company's remaining \$700 penalty, and approved a payment schedule for Luxury1 to pay the \$700 balance in four monthly installments of \$175.¹

Order 02 in Docket TE-180596 held that "If Luxury1 Limo, LLC, fails to pay any installment by 5 p.m. on the date it is due, the entire unpaid balance will immediately become due and payable without further order by the Commission." Order 02 further held that "If Luxury1 Limo fails to pay any portion of the \$700 penalty by the final due date under the payment plan, June 26, 2020, the Commission may cancel any charter and excursion service certificate issued to the Company by order in this docket."²

As of April 30, 2020, Luxury1 has failed to pay either of its first two installments or respond to Commission staff (Staff), despite Staff reaching out to the Company for status updates. Due to the Company's failure to abide by the conditions set in Order 02 and its failure to communicate

with Staff, Staff recommends the Commission cancel the payment arrangements in Docket TE-180596 and dismiss the Company's pending application in Docket TE-191008.
