Below are the stats for the Train Trestle at Old Hwy 99. Many incidents were due to accident on another route and trucks detouring down Old Hwy 99, especially this year. As you can see below the number of collisions and traffic control needed is increasing with each year. Note the time spent below, does not include time from the Fire department, Other LE agencies, or railroad response teams. There were also many collisions that occurred between smaller vehicles at the trestle that were not included below as they did not involve a semi or height clearance.

### <u>Jan 1 – Dec 13 2019</u>

- 27 semis disrupted traffic due to not being able to make it under the trestle.
  - The 27 semis occurred over 8 days. On two of those dates, multiple semis blocked traffic throughout the day.
    - 10/21/19 involved 13 Semis
    - 7/3/19 involved 8 Semis
- 6 of those the Semis hit the trestle
- 26 blocked traffic
- On average 2 of our deputies responded per call (min 0- max 4)
- Average Call length 54 minutes
- Average TCSO time spent for all deputies dispatched was 1 hour 23 minutes
- Total Time spent: 18 hours

#### <u>In 2018</u>

- 7 semis & 2 large vehicles (motor home & dump truck) disrupted traffic due to not being able to make it under the trestle.
- 2 Semis hit the trestle
- 9 incidents blocked traffic (including all 7 semis)
- On average 1.5 of our deputies responded per call (min 1- max 3)
- Average Call Length: 18 minutes 20 seconds
- Average TCSO time spent for all deputies dispatched was 24 minutes 47 seconds
- Total Time spent: 3 hours 43 minutes

#### <u>In 2017</u>

- 4 semis & 2 large vehicles (motor home & large truck) disrupted traffic due to not being able to make it under the trestle.
- 1 semi hit the trestle
- 6 incidents of blocked traffic (including all 4 semis)
- On average 1.2 of our deputies responded per call (min 0- max 2)
- Average Call Length: 21 minutes
- Average TCSO time spent for all deputies dispatched was 23 minutes 30 seconds
- Total Time spent: 2 hours 21 minutes

#### <u>In 2016</u>

• 2 Semis disrupted traffic due to not being able to make it under the trestle.

- 0 hit the trestle
- 2 incidents of blocked traffic
- On average 1.5 of our deputies responded per call (min 1- max 2)
- Average Call Length: 42 minutes 30 seconds
- Average TCSO time spent for all deputies dispatched was 1 hours 12 minutes
- Total Time spent: 3 hours 5 minutes

I'm going to work on the trestle at Mullen Road next, as it appears this one has an even larger impact on patrol. Let me know if you need anything else in regards to the grant application.
