Puget Sound Energy – Electric Tariff Revision**

Dear Mr. Johnson:

Pursuant to RCW 80.28.060, WAC 480-80-101 and WAC 480-80-105(1)(c), please find enclosed for filing the following proposed revisions to the WN U-60, Tariff G for electric service of Puget Sound Energy (“PSE”):

10th Revision of Sheet No. 83-G -Electricity Conservation Service (Continued)

The purpose of this filing is to update the 2020 through 2021 budget amount to implement conservation initiatives in electric Schedule 83. Consistent with Attachment A of Order 01 in Docket UE-190905, PSE filed a petition to modify its electric savings Targets and Thresholds incorporating the effects of the Clean Energy Transformation Act “CETA” to the degree possible. The Commission issued an Order 02 in Docket UE-190905 on May 21, 2020 approving PSE’s petition. This filing reflects an updated budget amount of \$193.88 million, an increase from an original amount of \$173.08 million, consistent with the updated budget amount included in PSE’s petition which was filed on November 1, 2019.

Consistent with WAC 480-109-110(1)(h) and condition (3)(e), PSE reviewed the proposed Conservation tariff revisions with the Conservation Resource Advisory Group (“CRAG”) on March 13, 2020. PSE received no comments or suggestions for revision changes.

The tariff sheet described herein reflects an issue date of May 21, 2020, and effective date of June 21, 2020. As required by WAC 480-100-193, PSE will post the proposed tariff sheet on the PSE web site coincident with the date of this transmittal letter.
