Pursuant to RCW 80.28.060 and WAC 480-80-101 and WAC 480-80-105(1)(c), please find enclosed for filing the following proposed revision to the WN U-60, Tariff G for electric service of Puget Sound Energy (“PSE”):

**94<sup>th</sup> Revision of Sheet No. 81      Schedule 81, Tax Adjustment**

The purpose of this filing is to implement the new six percent utility tax within the City of Burlington (the “City”) that will become effective on August 31, 2020. This is an increase of 100% from the existing three percent utility tax. A copy of the passed City Ordinance 1890 is enclosed. PSE estimates the resulting annualized increase in gross revenues from PSE’s electric operations within the City and the corresponding taxes due to be \$365,000.

The tariff sheet described herein reflect issue dates of July 31, 2020, and effective dates of August 31, 2020. Posting of proposed tariff changes, as required by law and the Commission’s rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-100-193. Pursuant to WAC 480-100-195, notice to customers will be provided in the first billing after the tariff revisions become effective. The 4,750 PSE customers within the City will receive notification in the form of a bill message.
