This is notice 480-30-186 (2) (b) for discontinuance of service. Shuttle Express will not be resuming service. Shuttle suspended service with WUTC filing on March 27, 2020. Our original intent was to resume WUTC licensed services within a few months. Resuming service after 8 months of suspension is not possible. During the last 6 months Shuttle has notified all vendors, communities, and the public requesting WUTC services for transportation. Shuttles largest notification vehicle is the internet. Shuttles has utilized the internet for notification that has existed for the duration of the ongoing suspension. All phone numbers, internet, and web booking have been transferred to Bayview Limo. Travelers seeking travel are served by Bayview Limo under their Department of Licensing Limo Licenses, (DOL). This service is nonstop direct service as authorized by DOL and in compliance of Washington State regulations for covid.

The public, all local agencies, vendors, and booking agencies (Expedia), have been notified over these past 8 months.
