On May 21, 2021, CenturyTel of Washington, Inc. d/b/a CenturyLink, filed Advice WA2101A, a tariff filing proposing the first step in implementing the 8YY Access Service reductions. This replacement filing replaces the proposed revisions originally submitted under Advice No. WA2101A (e-file confirmation 60a8015ea9527e40ecda5f62). The revisions proposed under that submission are included in this supplemental filing. This filing additional includes four revised pages in Section 17 for CenturyTel of Cowiche, Inc. d/b/a CenturyLink which were erroneously omitted from the original submission.

This filing proposes the first step in implementing the 8YY Access Service reductions mandated in the Federal Communications Commission's October 9, 2020 Report and Order in WC Docket No. 18-156, (FCC 20-143), (8YY Access Charge Reform).
