Good Morning Eric,

The proposed insured, Z G Trucking worked extensively with their current agent, another local office and the agent prior to the agent they are currently with. Both of those agencies, including mine, exhausted all admitted carriers. Every carrier was a decline due to a couple of factors:

- 1) Significant loss increase in the last 12 months
- 2) CAB score over 87 (which is an automatic decline for most admitted carriers)
- 3) OOS over double the national average. This can be worked with but the fact of 90% of these OOS have occurred in the past 12 months
- 4) Three recent citations for operation a CMV without a CDL

I hope this helps you have a better understanding of why we had to go to the Surplus market to get Z G Trucking their insurance. We had no other options.
