Dear Amazing Moving & Storage LLC:

The following items need to be completed and/or corrected for prompt processing of your application for operating authority. Please complete and return to our office by May 5, 2022. You may not operate until these issues are resolved and you have received your approved permit.

- **FINAL NOTICE!** This is your final notice. You must provide the required information

by (30 days from today) or your application will be dismissed and NO refund will be provided.

- We cannot proceed with this application under the name “Amazing Moving & Storage, LLC”. Under the provisions of [WAC 480-15-390\(2\)](#), “A carrier may not operate under a name that is similar to another carrier unless one of the following conditions applies:
  - (a) The carrier whose name is similar has given written permission to use the name.
  - (b) The commission authorizes use of the similar name. Before authorizing use of a similar name, the commission must first determine that the use of the similar name will not mislead the shipping public or result in unfair or destructive competitive practices.

Staff’s opinion is that Amazing Moving & Storage is too similar to an existing company, Amazing Movers 360. The owner of Amazing Movers 360 has indicated that he will not authorize the use of the name. Should this application proceed under the current name, Staff would recommend dismissal. Before the application would be dismissed, you would have the opportunity to request a hearing, where a judge would determine if item (b) above could be met. Staff would recommend that the use of the similar name could mislead the public.

I have discussed this issue verbally with your counsel, Christopher Wall. I would recommend that should you decide to proceed under a different name (other than A+ Moving, which would be completely fine) you may want to call me first (360-664-1223) to check the active permits within the state to make sure that this issue doesn’t come up again.

If changing the name requires a new UBI number, please provide that once you have it. Please ensure that the names on the ESD and L&I accounts are updated as well.

- Request a Uniform Motor Carrier Certificate of Insurance (Form E) and proof of Cargo Insurance (Form H) from your insurance company. The insurance must show your legal name, and, the Washington Utilities and Transportation Commission (WUTC) must be shown as the certificate holder. Please ask your insurance company to email the insurance to [transportation@utc.wa.gov](mailto:transportation@utc.wa.gov).
  - These filings will need to be under the new name you select for the company.
- Your DOT# will also need to be updated to reflect the new company name you select.
- New entrants typically complete household goods industry training. Since this transfer meets the requirements of WAC 480-15-187(2) to allow the transfer of a permanent permit without reverting to a temporary permit, training is not required, however should you wish to complete the training anyway, there are now virtual options available. There is a self-paced, computer-based option that you may wish to take.
