

JANUARY 28, 2022 CUSTOMER NOTICE

Blue Rock Water Company has filed with the Washington Utilities and Transportation Commission ("Commission") to approve 1) terminating (Rule 25) credit card chargebacks and associated fees (Schedule A), 2) migrating from a flat service charge fee of \$45 and \$65 to hourly fees billed in quarter-hour increments (Schedule A), 3) increasing the service connection fee from \$350 to \$950 to better reflect the value of connections within the operating region (Schedule 4) and a Winter No-read Period only for the Sunnyhills Water System (DOH ID# 23391F).

Blue Rock Water does not assess credit card chargebacks; therefore the change will have no impact on customers. The increased service connection fee will not impact current customers; it is for new connections only. The change to the service charge fee from flat to hourly could impact customers that request service work – it will mitigate the cost of service work requiring less time and increase the cost of service work that is more extensive. This only pertains to work 1) requested by customers or 2) found to be on the customer's side of the meter.

For the Sunnyhills Water system only, the Utility is proposing no meter readings between November and March each year. The Utility will bill the customer all applicable Monthly Charges except Usage Rates. Usage charges will continue to accrue during the Winter No-read Period, but they will not be payable until they can be measured. Customers will have the option of paying the accrued charges in a single payment or in equal payments over the same number of months as the Winter No-read Period.

The Commission has the authority to set final rates that may be lower or higher than the company's request, depending on the outcome of its investigation. You can submit comments by going to www.utc.wa.gov and clicking "Submit a Comment," or by one of the following options:

When the open meeting date (see above) appears, click on the memo for this filing - a page with the memo and any associated attachments will appear. You will be given an option to open or save the document you choose.
