Dear Ms. Maxwell,

Charter Fiberlink WA-CCVII, LLC (Charter) acknowledges that, in accord with the Federal Communication Commission's (FCC) Public Notice authorizing Charter for Rural Digital Opportunity Fund (RDOF) support released on March 15, 2022, the Washington Utilities and Transportation Commission (WUTC) will not include Charter in the WUTC's section 54.314 certifications for Eligible Telecommunications Carriers (ETC) until next year for the certifications due by October 1, 2023.<sup>1</sup> However, the WUTC has designated Charter as an ETC for the area in which Charter is authorized by the FCC to receive support from the RDOF,<sup>2</sup> and therefore Charter remains eligible to receive RDOF funding. Consistent with the FCC's Public Notice, Charter will complete state and federal reporting requirements for RDOF support beginning in 2023.
