The purpose of this tariff filing is to establish a new tariff schedule, Schedule 141CEI – Clean Energy Implementation Tracker, which will allow PSE to recover the costs of its Commission-approved Clean Energy Implementation Plan ("CEIP")¹ through a new tracker, in compliance with the Commission's Order No. 24/10². Such costs will include distributed energy resource costs; public participation plan costs; cost of tracking and monitoring CEIP progress; and O&M

expense and capital expense for any projects that enable the CEIP implementation. Schedule 141CEI is being filed as a subsequent filing consistent with WAC 480-07-885³, as this tariff schedule was not a filed tariff revision as part of the tariff schedules that initiated the proceeding.

Overall, this proposal represents a revenue requirement increase and an average increase for all customers affected by this tariff change, or a 0.90 percent increase in overall bills. A typical residential customer on Schedule 7 using 800 kWh per month would experience an increase of \$1.00 per month or 1.00 percent. Bill assistance programs are available to qualified customers who need help with their energy bills. PSE customers can go to pse.com or call 1-888-225-5773 to learn if they are eligible. Payment plans are also available.

The tariff sheets described herein reflect an issue date of July 17, 2023, and effective date of September 1, 2023. Posting of proposed tariff changes, as required by law and the Commission's rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-100-193. Notice to the public under the provisions of WAC 480-100-194 will be provided within 30 days of the September 1, 2023, effective date. As required by WAC 480-07-880(3) a copy of this compliance filing is being served on each party to the general rate case proceeding. The filing is being served via email.
