*** Present provisions are:**

Originally filed rates on 06/16/23 before audit of General Rate Filing by Staff and agreed upon by the Company.

*** Proposed changes are:**

Implement Tariff Rates that meet the company's revenue requirements as a result of a General Rate Case filing that was audited and approved by Staff and agreed upon by company.

*** Explain why the company is proposing this tariff revision:**

Administrative correction to implement rates agreed upon during audit between Staff and Company. The rates stamped by the UTC contain the original, un-audited rates that are higher than those rates agreed upon by staff and company that meet the company's revenue requirements
