Note 1: Permanent Service: Service is defined as no less than scheduled, every other week pickup, unless local government requires more frequent service or unless putrescibles are involved. Customer will be charged for service requested, even if fewer containers are serviced on a particular trip. No credit will be given for partially filled containers.

Note 2: In accordance with Douglas County Solid Waste Collection Fee Ordinance C.E. 94-014, the fee shown in each column above will be assessed each month. This fee will expire on **March 31, 2025 (C)**.

Note 3: Customers located in rural Douglas County residing in the areas designated in zip codes 98830, 98858 and 99115 as shown in Appendix E will be provided service only on every other week basis

**Accessorial charges assessed (lids, tarping, unlocking, unlatching, etc.):**

Note 4: A gate or obstruction charge of **\$12.93** will be assessed for opening, unlocking or closing gates, or moving obstructions, in order to pick up solid waste.

Note 5: A Fee of **\$27.47** per pickup will be assessed when containers with attached compactors require disconnecting or reconnecting.
