NOTICE OF OPPORTUNITY TO FILE WRITTEN COMMENTS (By Friday, July 23, 2021)

Re: Puget Sound Energy 2021 Transportation Electrification Plan Docket UE-210191

TO ALL INTERESTED PERSONS:

Pursuant to <u>RCW 80.28.365</u>, Puget Sound Energy (PSE or Company) filed its 2021 Transportation Electrification Plan (TEP) on March 19, 2021. Per the RCW, an electric company "may submit to the commission an electrification of transportation plan that deploys electric vehicle supply equipment or provides other electric transportation programs, services, or incentives to support electrification of transportation." The TEP may include proposed or planned future programs, along with the anticipated costs and benefits of those programs.

WRITTEN COMMENTS

The Washington Utilities and Transportation Commission (Commission) will accept comments on PSE's TEP. Written comments on the TEP must be filed with the Commission no later than **5:00 p.m. on July 23, 2021.** After its review of the comments, the Commission will place this item on a regularly scheduled open meeting. The Commission requests that comments be provided in electronic format to enhance public access, for ease of providing comments, to reduce the need for paper copies, and to facilitate quotations from the comments. Comments may be submitted via the Commission's Web portal at https://efiling.utc.wa.gov/Form or by electronic mail to the Commission's Records Center at records@utc.wa.gov. Please include the following details:

- The docket number of this proceeding (UE-210191).
- The commenting party's name.
- The title and date of the comment or comments.

Comments should be in .pdf format (created using Adobe Acrobat or comparable software) or in Microsoft Word. The Commission will post on its website all comments it receives in electronic format.
