- On November 26, 2001, Puget Sound Energy, Inc. filed with the Commission certain tariff revisions designed to effect a general rate increase in its rates for gas service in this state. It is indicated that the total effect of such tariff revisions is an increase of approximately \$85,900,000 (14.5%) annually. By order of the Commission, the operation of the tariff revisions have been suspended pending hearing or hearings concerning such changes and the justness and reasonableness thereof.
- Hearing in this matter is being held pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission has jurisdiction over this matter pursuant to Title 80 RCW, having legal authority to regulate the rates, services, and practices of gas companies. The statutes and rules involved, in addition to those previously cited, include those within chapters 80.04 and 80.28 RCW and chapters 480-09 and 480-00 WAC. The ultimate issues include whether the proposed tariff revisions are just, fair, reasonable, and sufficient and in the public interest. The ultimate issues also include whether Puget Sound Energy, Inc.'s current rates on file and effect with the Commission are just, fair, reasonable, and sufficient. These issues include consideration of alternative rate design or structure. In accordance with the provisions of RCW 80.04.130 the burden of proof to show that the proposed tariff revisions are just and reasonable shall be upon the respondent.
