RE: Rulemaking to Amend WAC 480-120-146, Changing service providers from one local exchange company to another. Docket No. UT-030964

TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made toward adoption of rule revision to WAC 480-120-146, Changing service providers from one local exchange company (LEC) to another. This letter also provides notice of an opportunity to file written comments on a Supplemental CR-102 proposed rulemaking related to the rule, and participate in the formal Supplemental CR-102 rule adoption hearing.

On October 22, 2003, the Commission continued the rule adoption hearing to December 10, 2003, in order for the parties to collaborate in drafting a new proposal to reflect national standards adopted by the FCC. Staff and the stakeholder group believe that the new proposal will differ substantially from the Qwest proposal, and thus will require a supplemental CR-102 as provided in RCW 34.05.340. On December 10, 2003, the Commission continued this matter to January 14, 2004, at which time Staff presented the new proposal.
