RE: *Washington Utilities and Transportation Commission v. Puget Sound Energy, Inc.*,
Dockets UE-070725 and UG-101581 (*consolidated*)

TO ALL PARTIES:

The Commission entered its Order 6 (Order), Granting Joint Petition for Approval of Joint Proposal and Request for Amendment of Order 03; Consolidating Proceedings and Granting Accounting Petition and Docket No. 101581, Order 01, Granting Petition for Accounting Order And Consolidating Proceedings (the "Order") on October 26, 2010. The order, approved an unopposed proposal submitted by Puget Sound Energy, Inc. ("PSE"), Commission Staff (Staff), and the Industrial Customers of Northwest Utilities that will result in bill credits to customers during the period November 2010 through March 2011, based on proceeds PSE received from sales of Renewable Energy Credits (RECs) through November 2009. In addition, Order 06 authorizes PSE to use a portion of the proceeds it receives from sales of RECs to offset Production Tax Credits already credited to PSE's customers but which the Company has not recovered via tax savings. The Commission authorized and required the Company to make compliance filings as are necessary to implement the terms of the Order and directed Staff to report to the presiding Administrative Law Judge whether filed tariff sheets comply fully with the relevant terms of the Commission's orders in Docket UE-070725. The order also authorized the Commission's Secretary to approve the authorized filing by letter if it complied with the terms of the order.

On October 27, 2010, PSE filed electric tariff sheets to comply with the Order. On October 28, 2010 the Company filed substitute tariff sheets based on Staff review. The Commission has examined the filing and it appears to comply with the terms of the order.

Therefore, pursuant to terms of the Commission's Order 6 in this proceeding, the tariff sheets indicated on the attachments to this letter will become effective as filed with an effective date of November 1, 2010.
