Important Notice for Washington Customers

Avista proposes 12.5 percent increase in electric rates and 1.8 percent increase in natural gas rates

On Mar. 30, 2005, Avista filed with the Washington Utilities and Transportation Commission (WUTC) a request to increase electric rates by an average of 12.5 percent and natural gas rates by an average of 1.8 percent. This filing is a general rate request proposed to be effective May 1, 2005, however, the WUTC will conduct a thorough investigation of the filing and can take up to 11 months to review and rule on the request.

Proposed Electric Price Increase

The proposed increase for electricity reflects increased costs associated with the generation and purchase of electricity to meet customer requirements, as well as increased costs associated with operating and maintaining Avista's electrical system. Earlier this year, Avista purchased the second half of the Coyote Springs 2 generating resource to meet current customer energy needs during certain months and increasing needs into the future. The purchase of this additional resource will allow Avista to be less dependent on market purchases and volatile prices. Additionally, Avista has had to invest millions to upgrade its transmission system in order to continue to provide reliable service to customers.

The proposed electric increase requests additional revenue of \$35.8 million annually, an increase of 12.5 percent over current revenue. The average proposed increase by customer class and rate schedule is as follows:

The difference in the proposed increase percentages for different customer rate classes is based on a comparison of the cost of providing service to those customers and the present rates billed for service. The proposed monthly increase for a residential customer using an average of 1,000 kilowatt-hours (kwhs) per month is \$7.92. The present bill for 1,000 kwhs is \$55.09 and the bill

with the proposed increase of \$7.92 would be \$63.01. The present and proposed rates for Residential Service Schedule 1 are as follows:

The proposed monthly increase for a small commercial customer (Schedule 11 or 12) using an average of 1,250 kwhs per month is \$8.68. The proposed increase for all customers will vary depending on their service schedule and monthly usage.

Proposed Natural Gas Price Increase

The proposed increase for natural gas requests additional revenue of \$2.9 million annually, an increase of 1.8 percent over current revenue. The proposed increase reflects increased operating costs associated with the delivery of natural gas to customers. The average proposed increase by customer class and rate schedule are as follows:

The difference in the proposed increase percentages for different customer classes is based on a comparison of the cost of providing service to those customers and the present rates billed for service. The proposed monthly increase for a residential customer using an average of 75 therms per month is \$1.48 or 2.0 percent. The present bill for 75 therms is \$74.77 and the bill with the proposed increase of \$1.48 would be \$76.25. The present and proposed rates for residential and small commercial customers served under Schedule 101 are as follows:
