On behalf of United States Cellular Corporation, LLC (“USCC”), please find attached copies of both the “confidential” and “public” versions of USCC’s FCC Form 690 Mobility Fund Phase I Annual Report Forms for Study Area Codes 528004, 528005, 528006, and 528007.
